5. Contestants are encouraged to have fun with this event. This is NOT a modeling contest or a pageant. We are looking for an attractive lady with a great personality that will represent the Emerald Coast Foundation in a positive way.
6. Any contestant who appears to be under the influence of drugs or alcohol shall not be allowed to compete in the "Miss Boat Week" contest. The Swamp and the Emerald Coast Foundation have the right to disqualify from the competition at any time, any contestant who fails to follow the rules of the "Miss Boat Week" competition or whose actions may cause any disturbance within The Swamp.
7. Upon entering the "Miss Boat Week" contest, contestants hereby grant permission to The Swamp, and to the Emerald Coast Foundation to reproduce any photographs or video for any purpose whatsoever, either now or in the future, and to use their names and likeness in any way deemed appropriate by the Emerald Coast Foundation, unless for use outside the Emerald Coast Foundation's publicity or in an indecent manner.
8. Contestant shall not hold The Swamp or the Emerald Coast Foundation, its assigns, sponsors or any of their representatives liable in any form or manner for any situations arising out of the competitions (physical or otherwise) or actions of any person or persons hired by The Swamp.
